

ST BURYAN & LAMORNA PARISH COUNCIL

Cemetery & Burial Fees

Effective from 1st April 2025

St Buryan, Lamorna & Paul Parish Council will keep a record of all interments and scattering of ashes within the Cemetery. All fees should be made payable on application to St Buryan, Lamorna & Paul Parish Council and addressed to the Clerk at clerk@stburylanlamorna-pc.gov.uk. The Council's preferred payment method is by direct banking payment/ BACS as detailed on our forms.

The fees set out below apply where the person to be interred (whether burial or interment of ashes) was a resident of the Parish or where there is to be a scattering of ashes.

A resident is defined as a person who fulfils one of the following criteria:

- a) Resides within the parish as date of death
- b) Has been a former resident of the parish
- c) Was a resident of the parish at the time they purchased an Exclusive Right of Burial.

Applications that do not meet the above criteria will be considered on an individual basis by the Parish Council and may be refused. If accepted, the fees are set out as 'Non Resident' below.

EXCLUSIVE RIGHT OF BURIAL

The Exclusive right of Burial (EROB) must be purchased for all plots. This means that the grave may not be reopened and no one may be buried there without your permission. You may permit others to be buried in the grave (space permitting), however you will not own the land itself.

Grave spaces are selected on rotation by the Parish Council and cannot be reserved in advance. For the exclusive right of burial for 50 years in an earthen grave.

Graves:

Size of base: 6'6" x 2'6"

Depths: Single 4'6" or Double 6'6" or Triple 8' (if ground permits)

INTERMENT

To place the body, or ashes, in their final resting place.

The Interment fee does not include the cost of digging the grave. Your funeral director will advise you in relation to these costs. It covers administrative and ongoing maintenance costs in respect of the cemetery.

Permits to Erect a Memorial

These fees are in addition to the cost of purchasing the grave or cremation plot as above. Fees in this section are charged at the same rate, whether a resident or non-resident of the parish.

Grave Headstone or cross not exceeding 4' in height (including first inscription)	£100
Grave Flat Stone not exceeding 6'6" x 2'6" x 3" (including first inscription)	£80
Fixed Vase	
Temporary Wooden Cross (to be replaced by permanent headstone)	No Charge
Cremation plaque not exceeding 18" x 18" and flat to the ground (including first inscription)	£30
Any other monument approved by the Parish Council	POA
Additional Inscription (per individual for records) on Grave Headstones or Flats	£25
Additional Inscription (per individual for records) on vases or plaques	£10

Exhumation from grave	POA
Exhumation from cremation plot	POA
Insufficient notice of Interment	£100
Transfer of EROB on our records (You will need to seek advice from your solicitor as to the legal process of transfer in a will)	£60
